OUTDATED REPORTING PROCESSES

Cleveland Independent School District (ISD) faced ongoing challenges related to bullying and violence. The district lacked adequate training for staff and students on how to respond effectively to threats. Reporting systems relied on handwritten forms, which often contained incomplete information or were misplaced. These inefficiencies led to delays in addressing incidents and limited the district's ability to maintain a safe environment.

NEED FOR COMPREHENSIVE SAFETY SOLUTIONS

Recognizing the need for an advanced safety system, Cleveland ISD began searching for a program that would both improve staff and student training, as well as streamline incident reporting.

ENHANCED STAFF TRAINING

The district implemented PublicSchoolWORKS EmployeeSafe to address safety training requirements. This system automatically assigned staff members a curated list of online safety courses, including topics like bullying prevention, suicide awareness, and recognizing depression in students. Supervisors were automatically notified of any training that was not completed, ensuring compliance without administrative burden.

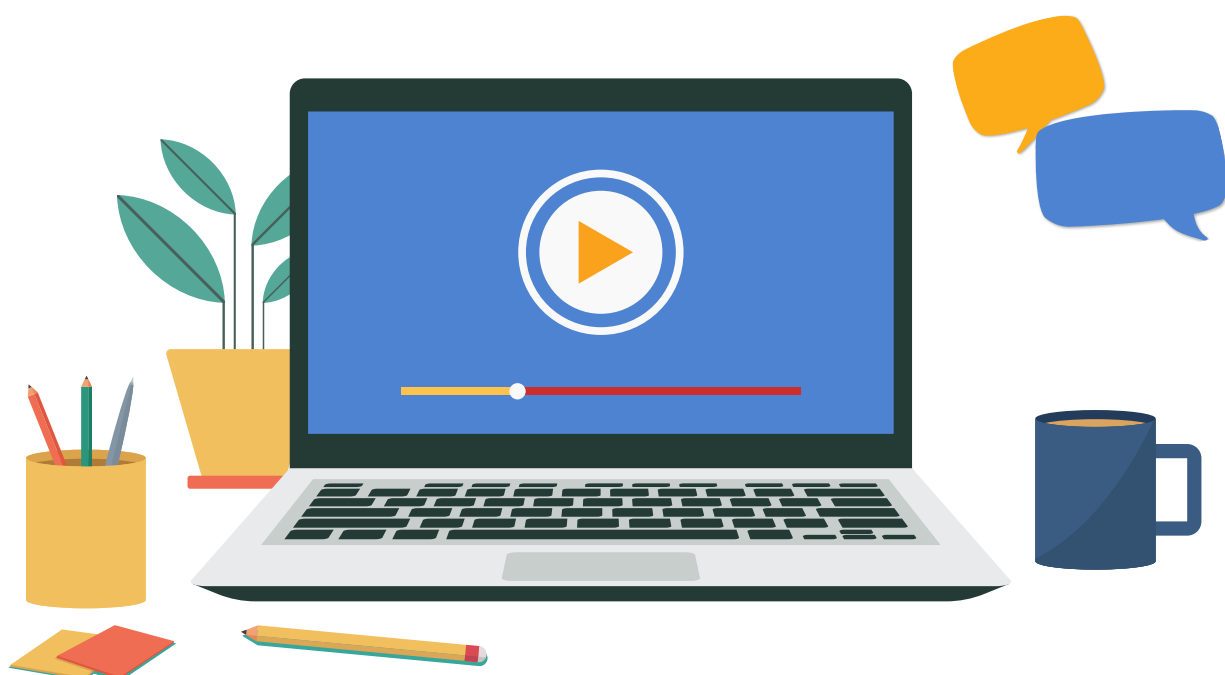
ANONYMOUS REPORTING FOR STUDENTS

Stay Safe. Speak Up! provided students with an accessible, confidential platform to report incidents. This tool allowed students to share concerns with district administrators quickly and effectively, ensuring a swift and informed response.

AROUND-THE-CLOCK SUPPORT

Through a 24-hour emergency hotline, students had access to live counselors who could provide immediate assistance with issues such as bullying, depression, or other concerns impacting their well-being.
