### MANUAL APPLICATION WAS A TIME-CONSUMING PROCESS FOR STAFF AND VOLUNTEERS

Using a pen-and-paper application process required potential volunteers to come to the school to pick up and drop off the application. Office staff would then have to manually enter that data into a spreadsheet for tracking purposes—a process that took considerable time to upkeep.


# AUTOMATE NOTIFICATIONS ABOUT APPLICATIONS
