# CHALLENGES BEFORE ADOPTING RAPTOR

## CREATING CONSISTENT COMMUNICATION PROTOCOLS

The district aimed to modernize its emergency communication processes. While they had adopted the Standard Response Protocol (SRP), there were opportunities to further streamline consistency across buildings. Ensuring every school had the same terminology and response guidelines was a priority.

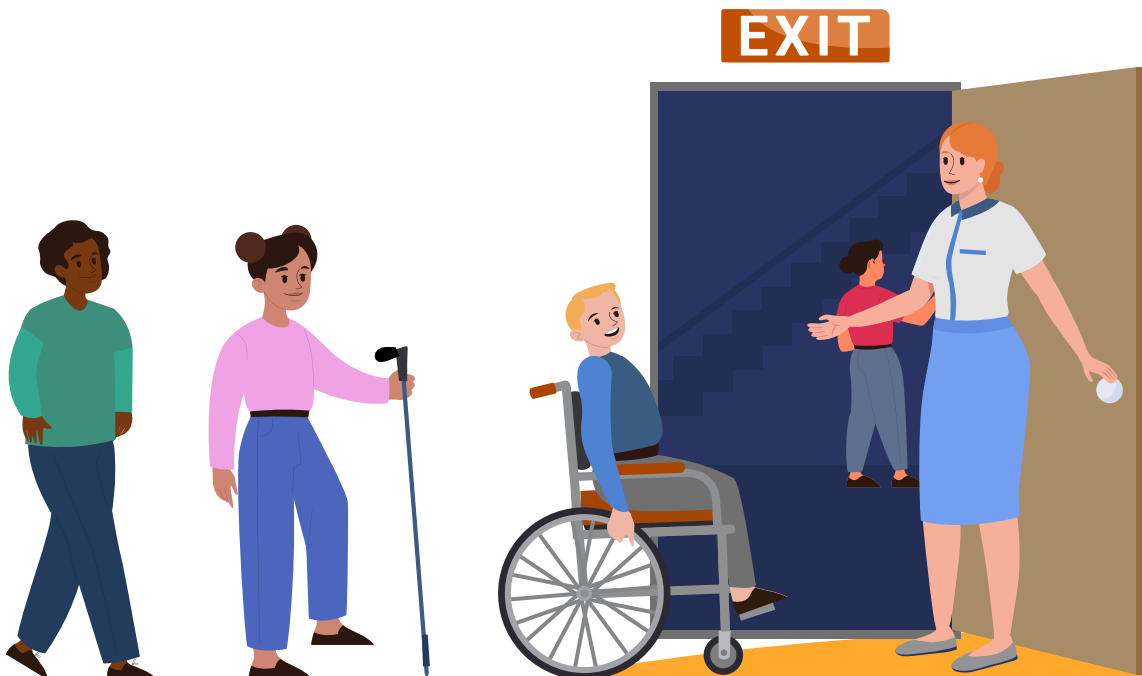
## STRENGTHENING DRILL TRACKING & COMPLIANCE

Administrators faced challenges in efficiently overseeing drill compliance across the district. Manual methods, such as spreadsheets, made it difficult to track drill activity and report compliance with state-mandated requirements. Additionally, principals often managed updates alongside active drills, which increased operational strain.

## ENHANCING ENGAGEMENT & PREPAREDNESS

The district prioritized fostering a stronger culture of engagement among staff during drills and emergencies—but they wanted to streamline their protocols to further support staff preparedness. They recognized that adding a tool that provides clear communication and seamless processes could empower teachers, staff, and administrators to work cohesively and confidently in real scenarios.
