Located in central New York state, Otsego Northern Catskills Board of Cooperative Educational Services (ONC BOCES) has 262 staff members and serves 19 districts across 1,661-square-miles.

The Challenge

Dependence on Key Personnel

Otsego Northern Catskills Board of Cooperative Educational Services (ONC BOCES) serves 19 school districts across 1,661 square miles in central New York State. For decades, the districts relied heavily on a single Safety Risk Officer. This officer not only managed compliance with federal and state safety regulations but also oversaw specialized tasks such as asbestos management, underground fuel storage, and safety inspections.

When the Officer announced her plans to retire after 20 years of service, ONC BOCES faced a critical challenge. They needed to minimize the risk of lost institutional knowledge and ensure her successor could seamlessly continue supporting nearly 3,000 district staff members and thousands of students.

Maintaining Compliance Across a Broad Area

With resources stretched thin across a large geographic region, ONC BOCES needed tools to standardize safety processes and provide consistent support for all 19 districts. The goal was to streamline compliance while maintaining the high standards set by the outgoing Safety Risk Officer.
